#### **Baltimore Fire Chief visits Remington**

The City's Fire Department was out in force in Remington on February 22nd. Several fire engines circled the neighborhood and firefighters were knocking on doors, passing out free smoke detectors and carbon monoxide detectors. Chief Niles Ford (pictured on left with Josh, a Huntingdon Avenue resident) was making the rounds and meeting new residents. He has only been on the job for a few weeks and it was his first visit to Remington.

A BCFD spokesman said that Department regularly makes such community visits when there is a fire-related death. In this case, a longtime Huntingdon Avenue resident was tragically killed in a house fire the previous week.

The spokesman noted that many fire deaths occur in homes that don't have working smoke detectors. Carbon monoxide, an odorless gas, is also a major concern. Thus the City provides free smoke and carbon monoxide detectors to any resident that wants them. To get your free detectors, just call 311.

#### **Street sweeping in Remington**

Baltimore Street Sweeping will expand citywide on Wednesdays beginning in April to stop tons of trash, grime and pollutants from ending up in the Chesapeake Bay. This will be adding 76,100 new route miles and increasing service from selected routes, mostly in the City's core, from today's 30% to 90% of all Baltimore City streets neighborhoods. Yes, including Remington.

Baltimore is under State and federal mandates to decrease levels of storm water pollutants entering our waterways. Increased mechanical sweeping is part of our plan to do so. Officials said the action also is necessary to clear trash from block-



ing storm drains and causing flooding during heavy rains.

Drivers are asked to move their vehicles on designated days to allow room for the mechanical sweeping. The sweeping will be on Wednesdays. There will be signs posted and postcards sent out to each household in the next month to specify which days and times your street will be swept. Street Sweeping will typically take place during daytime work hours when most vehicles will be off residential streets.

#### GHCC's 7th Annual Neighborhood Institute

This year's workshops include diverse issues such as: fundraising, social media, block captains, children and schools, Baltimore by the numbers, community projects, code enforcement, neighborhood branding, workforce development, and 21st century schools. The Neighborhood Institute is free of charge.

Mahan Rykiel is a landscape architecture firm in the Stieff Silver building, right on Remington's northern border with Hampden. The company was started in 1983 in founder Catherine Mahan's house. They moved to Mount Washington in 1993 and to their current location in 2001. The firm currently has 38 employees, some of whom live in greater Remington.

Mahan Rykiel specializes in all sorts of outdoor design and master planning. They have completed projects in 25 countries around the globe, and dozens of projects right here in Baltimore. Some of Mahan Rykiel's work will be familiar to many Remington residents: the brick sidewalks on Johns Hopkins University's Homewood campus, the Wyman Park Dell master plan, and improvements to several areas of Druid Hill Park were all completed by the firm.

Other notable Baltimore projects include the landscaping around Camden Yards, Spinnaker Bay condos in Harbor East, the St. Paul Street commercial district in Charles Village, and the corridor study for the Red Line.

Mahan Rykiel is currently working on a major project in Dubai, a master planned community surrounding the world's tallest building. So now you know that all these great ideas are coming from right here in Remington!
