## Clavel expansion, traffic flow changes on the horizon for lower Remington

You may have noticed that construction has begun at the very popular Clavel restaurant and bar on the 200 block of W 23rd Street to add 50 seats adjacent to the restaurant's main dining room. The expansion should help accommodate the restaurant's tremendous demand and also reduce the number of patrons who congregate outside of the establishment.

In addition to this modest expansion, the restaurant is in the process of applying for approval to conduct "live entertainment" in the establishment. A live entertainment license will allow Clavel to host Latin dance nights and private events like wedding parties. Patrons of the popular establishment currently endure wait times of up to two hours for a seat in the dining room.

On August 1, the Greater Remington Improvement Association's (GRIA) Land Use Committee, joined by over a dozen neighbors from lower Remington, heard a presentation from Lane Harlan, the owner of both Clavel and nearby W.C. Harlan, on her plans for expansion and entertainment. The committee voted unanimously to support the request for a live music license. The GRIA Board gave the request final approval on August 9th. The proposal will now move onto the Board of Municipal and Zoning Appeals for public hearing with a date to be determined.

In tandem with the business expansion, additional parking and better traffic flow along the majority of streets in Remington's southernmost blocks are to be expected soon. Baltimore City's new Director of Transportation Michelle Porciau is reviewing proposals from GRIA and City Department of Transportation staff to prevent the queuing of taxis at Veolia on the corner of Huntingdon and 21st Street and encourage business patrons to park on



the non-residential blocks in this part of the neighborhood.

Reversing the flow of traffic on the 2300 block of Huntingdon, so that traffic runs north from 23rd Street to 24th Street, and adding to new signage encouraging business patrons to park on this block should put the roughly 40 parking spaces into productive use. Converting traffic alignment on the 2200 block of Huntingdon, as well as removing outdated signage, should create 8 parking spaces on the block.

Harlan said that she and the rest of her team, "standby the voices of the neighbors," and are actively working with direct neighbors, GRIA, and the Department of Transportation to alleviate parking challenges. "We want to be an asset to the neighborhood," she stated. **R**
